#### Section IV: First aid measures

<u>General</u>: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

<u>Inhalation</u>: Remove to fresh air, keep patient warm and at rest, if breathing is irregular or stopped, administer artificial respiration. Give nothing by mouth. If unconscious place in recovery position and seek medical advice.

<u>Skin contact</u>: Remove contaminated clothing. Wash skin thoroughly with soap and water or use recognised cleaner. Do NOT use solvents or thinners.

<u>Eve contact</u>: Irrigate copiously with clean, fresh water for at least 10 minutes holding the eyelids apart and seek medical advice.

<u>Ingestion</u>: If accidentally swallowed obtain immediate medical attention. Do NOT induce vomiting.

Section V: Fire-fighting measures

Extinguishing media: Recommended: Alcohol resistant foam, CO2, powders, water spray

Not to be used: Water jet

<u>Recommendations</u>: Cool packaging which are exposed to fire with water. Take care that extinguishing materials do not run into surface water drains.

#### Section VI: Accidental release measures

<u>Recommendations for the protection of individuals</u>: Exclude sources of ignition and ventilate the area well. Avoid breathing vapour. Refer to the protective measures listed in sections VII and VIII.

<u>Ecological measures</u>: Do not allow to enter drains or watercourses. If the product does contaminate lakes, rivers, or surface water drains, inform appropriate authorities in accordance with local regulations.

<u>Disposal measures</u>: Contain and collect spillage with non-combustible absorbent material; sand, earth, vermiculite, diatomaceous earth and place in container for disposal according to local regulations (see section XIII). Do not allow to enter drains or watercourses. Clean with a suitable water based detergent; avoid use of solvents.

Section VII: Handling and storage

<u>Handling safety advices</u>: Avoid skin and eye contact. Avoid inhalation of vapour and spray mist. Smoking, eating and drinking should be prohibited in application areas. For personal protection see section VIII. Also follow legislative protective- and safety instructions.

<u>Fire/Exposure protection advices</u>: Keep the packing well closed. Protect against frost, heat and naked flames.

Storage:

<u>Demands on storage/containers</u>: Store in accordance with local regulations. Keep container tightly closed. No smoking. Prevent unauthorised access. Keep the container in upright position, to prevent spillage.

<u>Storage</u>: Keep away from sources of ignition. Keep away from oxidising agent from strongly alkaline and strongly acid materials.

<u>Storage conditions and instructions</u>: Always keep in containers of same material as the original one. Observe label precautions. Store between 5° and 30° C in a dry, well ventilated place away from sources of heat and direct sunlight. Isolate from sources of heat, sparks and open flame.

#### Section VIII: Exposure control/personal protection

<u>Ventilation measures</u>: Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations particulate and solvent vapour below the OEL, suitable respirator protection must be worn.

<u>Personal protection</u>: When workers facing concentrations above the exposure limit they must use appropriate certified respirators.

# Section VIII: Exposure control/personal protection, continued

<u>Hand protection</u>: For prolonged or repeated contact, use PVC or rubber gloves. Barrier creams may help to protect the exposed areas of the skin, however, these should not be applied once exposure has occurred.

Eye protection: Use safety eye wear designed to protect against splash of liquids.

Skin protection: All parts of the body should be washed after contact.

# Section X: Stability and reactivity
